1.0 Introduction

- 1. This report constitutes a Pre-Application Consultation (PAC) Report which describes the consultation requirements for the proposed development, Kirkton Energy Park, the consultation measures undertaken by the developer Kirkton Wind Farm Limited (the applicant), the feedback received and any resultant modifications to the proposed development.
- 2. The applicant recognises that it is very important to ensure that communities in the vicinity of the development are afforded appropriate and meaningful opportunities to comment on the proposals before they are finalised in accordance with regulations and good practice guidance.

1.1 Site Location and Description

- 3. The Kirkton Energy Park would be located approximately 2.1km south of the settlement of Melvich, Sutherland. The location of the site is centred on NGR NC 87999 59788, is shown on **Figure 1** and is within the administrative boundary of The Highland Council (THC).
- 4. The site area, which measures approximately 419.38ha (including the two potential abnormal load turning areas), is currently used mainly as grazing land. Topography ranges from approximately 20m AOD to 160m AOD with the western extent of the proposed site forming the most elevated section.
- 5. Access to the site is expected to be from the A836, taking the Kirkton Farm road (near Loch Mor) southward to Kirkton Farm and then continuing south to where turbines would be located.
- 6. For abnormal loads coming from the east (Port of Scrabster) to access the Kirkton Farm road, it will be necessary for the vehicles to continue on the A836 past the Kirkton Farm road entrance, turn, and approach from the north / west. As a result of this, two potential turning areas (only one would be developed) have been designed and are included as part of the Section 36 application (**Figure 1**).
- 7. The site is characterised by sweeping moorland and flows, with a relatively small amount of coniferous woodland plantation to the north of the site. A number of small tributaries run through the site and join the larger Halladale river to the east.

1.2 The Proposed Development

- 8. The proposed development would comprise of up to 11 three-bladed horizontal wind turbines, with associated infrastructure. It is proposed that each of the turbines would be rated at a capacity of 4.8MW, giving a total installed capacity in the region of 52.8MW. The proposed development would also include up to 20MW of battery storage. The final layout for the proposed development is shown in **Figure 2**. The key component parts of the proposed development include the following:
 - 11 wind turbines including internal transformers, with blade tip heights of up to 149.9m;
 - 11 turbine foundations (approximately 25m in diameter) and associated crane hardstandings (approximately 35m x 35m and 1m in depth, with an area for additional crane pads that is 85m x 5m);
 - approximately 2.03km of upgraded access tracks, and approximately 5.48km of new access tracks with a typical 5m running width and associated drainage. 446.95m of the new track is anticipated to be floating track, where consistent peat depths of 1-1.5m or greater are identified along with shallow topography in the area (below 5%);



- approximately 7.5km underground cabling along access tracks to connect the turbine locations, and the onsite electrical substation;
- one onsite substation which could accommodate 33kV Switchgear to collect electricity from different parts of the site. The substation compound, which will incorporate up to 20MW of battery storage, would have an area of 75m x 100m and would include a control and metering building (approximately 14m x 23 m and 7m high);
- up to 2 borrow pit search areas (covering approximately 32,000m²);
- a temporary construction compound (125m x 50m);
- clearance of 87.75ha of conifer forest (net area of 70.75ha bearing trees); and
- clearance of 3.58ha of native woodland.

1.3 The Applicant

- 9. The applicant will be Kirkton Wind Farm Limited, a company which is part of a joint venture between Wind2 and companies managed by Octopus Energy Generation.
- 10. The founders of Wind2 together with the Wind2 team have a substantial track record in the successful development of onshore wind throughout the UK being responsible for the delivery of approximately 1GW of renewable energy through their involvement with RDC Partners and West Coast Energy, sold to ENGIE in 2014. Wind2 is working on the development of a number of subsidy free renewable energy projects, including the consented 38MW Ben Sca Wind Farm on Skye, is committed to investing the Highlands, has personnel based in the Highlands and has opened an office on the Black Isle in 2020.

1.4 SLR Consulting Limited

1.5 Public Consultation Guidance and Legislation

- 14. In conducting its public consultation programme for the proposed development, the applicant has complied with the legal requirements set out by the Scottish Government and guidance set out by THC.
- 15. The applicant believes that a meaningful and far-reaching dialogue with the local community is essential to the sustained success of any development and that legislative requirements provide a minimal framework of what should be expected of a developer in terms of consultation.



16. The consultation programme described in this report demonstrates that policy and guidance requirements have been exceeded and that a thorough and constructive community engagement process, has underpinned the final proposed design being put forward.

1.6 Legislation

- 17. The Town and Country Planning (Hierarchy of Developments) (Scotland) Regulations 2009 apply to developments across Scotland and sets out various criteria that are to be used to differentiate planning applications by development types and to define developments as either National, Major or Local developments. That differentiation is used to ensure that applications are dealt with in an appropriate way to their scale and complexity, allowing decisions to be taken at the most appropriate level.
- 18. Proposals for wind farms with a potential electrical capacity greater than 50 megawatts (MW) are subject to the consenting procedures set out in Section 36 of the Electricity Act 1989 (the Electricity Act), the Electricity (Applications for Consent) Regulations 1990 and the Electricity Works (Environmental Impact Assessment) (Scotland) Regulations 2017. Applications are made directly to the Scottish Ministers. As the proposed development is for an Energy Park in excess of 50MW, an application is being made under the Section 36 process.
- 19. There is no statutory obligation to consult the public under the terms of the Electricity Act application process. Nevertheless, Wind2 has applied the principles of the consultation process recommended for 'major' planning applications as set out in The Town and Country Planning (Development Management Procedure) (Scotland) Regulations 2013 and Planning Circular 3/2013 Development Management Procedures. This enables the local community and all those with an interest in the proposals a clear opportunity to provide comment and feedback on the proposals. Wind2 have also had cognisance of The Town and Country Planning (Pre-Application Consultation) (Scotland) Amendment Regulations 2021, when putting together a programme of public consultation.

1.7 Report Structure

2.0 Consultation Measures

21. **Table 2-1** provides an overview of the stages of consultation undertaken for the proposed development.

The Posters are shown in Appendix 02. 546 leaflets (for each Public Exhibition, so over 1000 in total) were distributed to residents within a 10km radius of the site and included Melvich, Portskerra and the residents of Strath Halladale. An example of the leaflet is provided in Appendix 03.

2.1 Scoping

- 22. In March 2021 an EIA Scoping Report was prepared and submitted to The Energy Consents Unit (ECU) to accompany a formal request for the Scottish Ministers to provide a Scoping Opinion. Shortly prior to receiving the Scoping Opinion from the Scottish Ministers, the Applicant reached agreement on an option area for land immediately to the south of the site boundary presented in the March 2021 Scoping Report. As a result of this, the site boundary was extended southward. A Scoping Addendum was subsequently submitted on 01 July 2021 detailing the inclusion of two additional turbines and a further, approximately, 45.46ha of land to be included in the EIA.

- 24. The Scottish Ministers issued their scoping opinion on 08 June 2021. Consultation responses received as part of the Scoping process have been considered in the EIA and the issues raised are reported in **Chapter 6** of the EIA Report, as well as in the individual topic Chapters of the EIA Report as relevant.



- 25. The following consultees provided responses to the Scoping Addendum Report:

- 26. The ECU formally closed the Scoping Addendum consultation on the 01 of September 2021. The Scottish Ministers did not issue an updated Scoping Opinion from that of 08 June 2021. Consultation responses received as part of the Scoping Addendum process have been considered in the EIA and the issues raised are reported in **Chapter 6** of the EIA Report, as well as in the individual topic Chapters of the EIA Report as relevant.

2.2 Pre-Application Advice Meeting

- 27. A formal Pre-Application Advice meeting was held with THC on 13 January 2021 to discuss Kirkton Energy Park, key design issues and other important topics relating to the proposed development and its EIA. The ECU and NatureScot were also in attendance at this meeting.
- 28. Key issues discussed at the meeting included:
 - The potential layout and scale of the proposed development;
 - East Halladale Flows Wild Land Area;
 - Environmental Designations (SSI/SPA);
 - Cumulative considerations with nearby proposed and consented wind farms e.g. Ackron and Drum Hollistan (*noise, visibility etc.*);
 - Landscape & Visual considerations (including the views from the A836, LCT's, coastal and summit viewpoints); and
 - Peat Management.

2.3 Community Council Consultation

- 29. The applicant has kept three Community Councils and other community bodies, local to the proposed development, informed of the project progress and sent emails to confirm dates of the Public Exhibitions held on the 06 of October 2021 and 16 of March 2022 (see emails to the Community Council's Appendix 04). The three Community Councils are:
 - Melvich Community Council;
 - Caithness West Community Council; and
 - Strathy and Armadale Community Council (currently in abeyance).
- 30. Representatives of the applicant attended meetings of the Caithness West Community Council on 24 May 2021 and Melvich Community Council on 27 May 2021 (both meetings were online due to COVID restrictions) to present information on the proposed development. The Chairperson for the Strathy & Armadale Community Council was also contacted but the applicant was advised that the community council was not active at the time.

2.4 Consultation with Other Organisations

- 31. Emails confirming the dates of the Exhibitions were sent to the following Councillors, MPs and MSPs (the emails are provided in **Appendix 05**):
 - Ward Councillors (North, West and Central Sutherland) Kirsteen Currie, Hugh Morrison, Linda Munro;
 - MP (Caithness, Sutherland and Easter Ross) Jamie Stone;

2.5 Public Exhibitions

- 32. Public Exhibitions were undertaken in October 2021 (in-person) and March 2022 (virtual), to establish dialogue with the local community regarding the proposed development. The first Public Exhibition was held in-person at Strathy Community Hall, approximately 2km west of the proposed Kirkton Energy Park site. The second Public Exhibition was held virtually on 16 of March 2022.
- 33. Further information on the Public Exhibitions is presented in Section 3 of this report.

2.6 Website

34. The applicant hosts a page dedicated to the proposed development on its website to allow people to view details about the development and contact the project team for further information: https://kirktonwindfarm.co.uk.



3.0 Public Exhibitions

3.1 Location

- 35. The first Public Exhibition was held, in-person, at Strathy Community Hall in October 2021, with a follow up Exhibition held virtually in March 2022 (see **Table 3-1**).
- 36. Strathy Community Hall was chosen because of its proximity to the proposed development, booking availability, and also its relatively large size (aiding with Covid-19 precautions). The event was open from the afternoon to the evening to try to maximise opportunities for people to attend.
- 37. The second Public Exhibition was held virtually so that people who could not, or did not want to attend an in-person event (due to either COVID-19 concerns or convenience), could still interact with the project team and see the proposals for Kirkton Energy Park.

3.2 Notification

38. In keeping with Regulation 7 of the Town and Country Planning (Development Management) (Scotland) Regulations 2013, the applicant advertised that a pre-application public event was being arranged to publicise a forthcoming Section 36 application to Scottish Ministers, for a development within the area. The Exhibitions were advertised in several ways to help ensure as many local residents as possible were made aware of the proposed development.

3.2.1 Newspaper Adverts

- 39. A public notice was placed in the Northern Times and John O'Groats Journal Press for both the in-person event in October 2021 and the virtual event in March 2022. The public notices set out the purpose of the public events and provided details of the events.
- 40. The public notices were provided more than 7 days prior to the event with the first notice being published in the Northern Times and John O'Groats Journal Press in September 2021 and the second being published in March 2022. A copy of the notices are provided as **Appendix 01**.

3.2.2 Leaflets

41. In advance of the Public Exhibitions, the applicant distributed leaflets to approximately 541 households (for each Exhibition) within approximately a 10km radius of the site, which included Melvich, Strath Halladale, Portskerra, Strathy and Reay. The leaflets set out the purpose of the public events, provided details of the event and contact details for further information from the applicant. A copy of the leaflets are provided in **Appendix 03**.



3.2.3 Social Media

42. Melvich Community Council advertised both Exhibitions on their Facebook page in September 2021 and March 2022

3.3 Exhibition Boards

43. The exhibition boards that were on display at the Public Exhibitions are contained within **Appendix 06**. The information presented included plans for the proposed development, an outline of the planning process including details about an environmental impact assessment and survey work, and information about community and local economic benefits.

3.4 Consultation Feedback

- 44. Scottish Planning Policy (SPP) (paragraph 6) notes that throughout the planning system, opportunities exist for everyone to engage in the development decisions which may affect them. Engagement should be early, meaningful and proportionate. Expressions of support and concern should be taken into account in developing proposals.
- 45. Attendees to the Public Exhibitions were invited to complete a feedback form (**Appendix 07**) about the proposed development. 15 people attended the in-person exhibition, and three feedback forms were returned (20%). 30 people attended the virtual/online exhibition, and one feedback form was returned (3.3%).
- 46. Comments suggest that out of the four respondents, three are in support of the proposed development; and one is opposed to it. A summary of comments received is presented in **Table 3-2**.

- 47. In addition to the written responses, verbal feedback covered many topics, with many attendees asking for more information about:
 - the potential for shared ownership; and
 - the proposed community benefit (including the near neighbour energy contribution scheme).
- 48. All topics and questions raised through the consultation have been addressed in the EIA Report for the proposed development.



4.0 Shared Ownership Consultation


49. Separate to the consultation on the Section 36 application for Kirkton Energy Park, there is ongoing dialogue between the applicant and the Farr North Community Development Trust regarding the opportunity for shared ownership. Farr North is the Community Development Trust for the Parish of Farr including Forsinard, Melvich, Portskerra, Strathy, Armadale, Bettyhill, Strathnaver and Altnaharra. It was established August 2020 with the objective of improving the lives of the people living in North Sutherland. The Trust would most likely be the vehicle for the community shared ownership investment. At the time of publication of this PAC Report and EIA Report, a draft Memorandum of Understanding (Prepared by Wind2 with the assistance of Local Energy Scotland) is being discussed by representatives of the applicant and the Development Trust.




5.0 Conclusion

- 50. An extensive programme of pre-application consultation activities has ensured maximum awareness within the community of the project. The applicant also focused on making sure that residents and community groups were able to make comments on the proposed development and receive feedback if requested throughout the process via a number of different channels.
- 51. The applicant consulted with the general public, local councillors, MP and MSP, and a number of community groups in the consultation area. The consultation programme has included regular meetings, emails, phone calls, and correspondence as well as household and business newsletter distribution, press releases, newspaper advertisements, posters, social media and website updates.
- 52. The applicant has maintained a flexible and pro-active approach to the public consultation programme and exceeded the minimum statutory consultation requirements. This approach has helped ensure that the community has remained consistently well-informed and been given regular opportunities to provide feedback.
- 53. The applicant engaged at an early stage with the local community to facilitate a constructive consultation process which has helped the developer to understand and attempt to address any concerns raised as the project developed. This has resulted in a high-quality development proposal that represents a careful balance between the views of the community, environmental impacts, views of statutory consultees and the economic viability of the project.
- 54. Consultation on the Community Share Ownership offering has also been undertaken with local community organisations, in conjunction with Local Energy Scotland, as a separate exercise. This consultation process regarding the potential for community shared ownership will continue while the S36 application is being considered.


